Position: Airport Maintenance

Summary: Reporting to Operations Manager the Airport Maintenance (AM) person performs troubleshooting, inspection, installation, and repair of a variety of complex mechanical equipment and systems. The AM is responsible for detecting and diagnosing correct operating parameters such as pressures, temperatures, time ranges, concentration levels; adjusting and regulating equipment using the central and local control panels to ensure the comfort and safety of facility users and to minimize downtime of equipment; implementing procedures for the proper use and care of tools and equipment and the storage, inventory, and cost-effective use of supplies, and safety.
